SPECIFIC ISSUES OF INTEREST TO THE CCB:

Canada New Labeling Requirement Enforcement Begins

- On January 15th, Canada will begin enforcement of new labeling requirements for fresh fruits and vegetables, as mandated under Canada's [Safe Food for Canadians Regulation](#) (SFCR) which entered into force on January 15, 2020, with a one-year extension on enforcement.
- Fresh fruits and vegetables must be labeled with the following information, as [defined](#) in the SFCR:
 - Name and principal place of business of the person by whom or for whom the food was manufactured, prepared, produced, stored, packaged, or labeled
 - Fruit grade, where applicable
 - Net quantity, where applicable
 - Country of Origin
 - Lot code or unique identifier
 - Other labeling information, as applicable, including common name, variety name, list of ingredients, and irradiation symbol
- The Canadian government has provided a summary of [general labeling requirements](#) and [traceability-specific labeling requirements](#) under SFCR.
- A *lot code* is defined in the [SCFR: Glossary of key terms](#). Canada's Food Inspection Agency (CFIA) provides that the following items are also permitted to be used as a *unique identifier*, according to a [USDA GAIN Report](#):
 - Harvest Date
 - Grower identification number
 - GPS coordinates
 - Growing region (must be sub-national, state-level is accepted)
- Fresh fruits and vegetables exempt from the *lot code/unique identifier* requirements include:
 - Not consumer prepackaged (e.g. bulk display foods)
 - Prepackaged in a wrapper or confining band less than 13 millimeters in width
 - Packaged in a protective clear and transparent wrapper or bag which shows no additional information beyond price, bar code, number code, environmental statement, or product treatment symbol

GENERAL ISSUES OF INTEREST TO THE CCB:

USDA Announces New Weekly Data Report on Seasonal Perishable Products

- The USDA [announced](#) a newly established data report, the [U.S. Mexico Canada Agreement Seasonal Perishable Products Weekly Update](#). The new report will be prepared in conjunction with the U.S. Trade Representative (USTR) and U.S. Department of Commerce (USDOC) with data from the Agricultural Marketing Service (AMS).
- The report will include easy-to-read descriptions of market trends on key imported specialty crops and commodities covered will vary by season and crop cycles. The report aims to satisfy the need for near-real time market information as highlighted in the USDA, USTR, and USDOC joint report on [Seasonal and Perishable Products in U.S. Commerce](#), released in September 2020.

Vietnam Publishes National Technical Regulation on Quarantine Pests

- Vietnam's Ministry of Agriculture and Rural Development (MARD) has published a National Technical Regulation (NTR) establishing a zero tolerance policy for regulated quarantine pests in imported plant products. The NTR was promulgated in MARD Circular 15/2020 dated December 25, 2020; an unofficial English translation of the Circular is available via a recent [USDA GAIN Report](#).
- Section 2 of the NTR provides phytosanitary inspection details and Section 2.3.1 sets a zero tolerance policy for the regulated quarantine pests listed. The list, established in MARD Circular 35/2014, is divided into categories of insects, mites, fungi, bacteria, viruses, nematodes, and weeds.
- Circular 15/2020 enters into force on June 25, 2021.

USDA Publishes GAIN Report on EU Food Labeling Revision Roadmap

- The USDA recently published a new [GAIN Report](#) summarizing the European Commission's roadmaps of proposed changes to labeling requirements, as reported in last week's BCI Monitor (*BCI Monitor 1-5-21*).
- The EU is considering revisions to requirements on Front-of-Pack (FOP) nutrition labeling and nutrient profiles, expanding mandatory origin labels for new product categories, and expiration dates as part of the Farm to Fork Strategy.
- Comments are due by February 3, 2021.
